Shipper or Agent does not need to fill or sign this form, only Air SERBIA employee or Air SERBIA authorized representative must complete the below form and sign off. A duplicate copy must be attached to Air Waybill.

Prior to acceptance of freight examine all documentation (for example Air waybills or House Air waybills, HAWB manifest) to determine the name and physical address of shipper represented in the cargo shipment.
